Tarena International, Inc. Launches TMOOC.CN to Offer Online Education Products

These recruitment-oriented courses are carefully chosen from existing courses at Tarena learning centers and redesigned to be more suitable for online learning environment. Students who finish all modules in a placement training course and pass the relevant Tarena certification examination will receive the same job placement services offered by Tarena as enjoyed by other students at learning centers.

"TMOOC.CN sets an important milestone for Tarena as the platform will extend Tarena's footprint beyond entry-level training to lifelong professional education services that will accompany professionals throughout their career. Continuing education courses will equip working professionals with advanced practical knowledge of real application values to help them advance in their careers," said Shaoyun Han, founder, CEO and chairman of Tarena. "The job placement training courses will be a hybrid model pursuant to which approximately 80% of the study will be completed online and 20% will be spent at existing learning centers in order to better address questions that students may encounter. This hybrid model will greatly enhance students' learning experience and also improve learning centers' utilization. Moreover, we believe that only with Tarena's broad national network of 118 centers in 37 cities, can this hybrid model be efficiently operated. We expect that through TMOOC.CN, our students will not only master the foundational skills necessary to launch their careers, but also continue learning at our platform to strengthen their competitiveness throughout their careers."
